1. All BBQ Teams, member, guests who submit their registration are agreeing to abide by the Rules, Regulations, & Information as set forth in this Document. This Document is attached to all Registration Forms and can be found at www.shkofcbbq.weebly.com
2. Full payment must be made at the time your registration is submitted. Application is not transferrable to another team.
3. The K of C BBQ Smoke Off “4-Life” event is held rain or shine. **No refunds will be given.**
4. Alcoholic beverages are allowed in the designated confines of the BBQ area. All city & state liquor laws will be adhered to by teams and guests and will be enforced by city law enforcement.
5. We strive to maintain a family friendly & enjoyable atmosphere during the competition. The BBQ Smoke Off “4-Life” Committee reserves the right to require teams to limit inappropriate language, remove inappropriate items, etc. from the event.
6. K of C BBQ Smoke Off “4-Life” competition is a sanctioned competition by the Kansas City Barbeque Society (KCBS)
7. Total prize money for K of C BBQ Smoke Off “4-Life” is \$5,000. Cash prizes, trophies, and ribbons are awarded in four categories; Pork Ribs, Chicken, Pork and Brisket.
8. Optional Sausage Contest pays 50% of the sausage entry fees to the top 4 finishers.
9. Sides Contest: BBQ Beans, Bloody Mary, Dessert & Margaritas. Cost is \$20 for each item. Pay back is 50% of the entry fee for that item. Ex. If 3 people enter dessert for a total of \$60, the first-place winner will receive \$30 and a ribbon. 2nd and 3rd place will receive only a ribbon. Bloody Mary, Margaritas and Beans are NON-KCBS events.
10. Acceptance of BBQ Teams is at the sole discretion of the K of C BBQ Smoke Off “4-Life” Committee.
11. BBQ Teams can purchase one 110-volt **15-amp** outlet, for \$30. There are **NO 220 volts or 30-amp plugs**. Please bring your own generator if one 110-volt 15-amp outlet is insufficient. **15 amps WILL NOT run your AC**
12. Previous year BBQ Teams will be assigned their previous competition year’s space unless otherwise requested by the BBQ Team. New Teams will be placed in a first come first serve fashion.
13. There will be a **\$35 NSF Fee** charged for returned checks. This fee, plus the full fee must be paid in cash or money order **before** the competition.
14. The K of C BBQ Smoke Off “4-Life”, Knights of Columbus, Sacred Heart Church and/or Our Lady of Unity Parish are not responsible for any lost, damaged, or stolen items; or responsible for accidents, injury, or illness.
15. BBQ teams shall keep their space clean of litter and trash throughout the competition. Teams will need to dispose of their trash on a regular basis in the dumpster provided.
16. **Each team must be self-contained; there will not be any walk around room between your space and the space next to you. Trailers, tables, items, coolers, grills, etc., will need to fit in your designated space of 20x30 feet. A 2nd 20x30 space can be purchased for an additional \$100. Please include with entry fee and make note on entry form.**
17. NO vehicles can leave the designated competition space after 7 pm Friday. If you need to leave you must park your vehicle in the visitor parking. Due to close configuration of teams and pedestrian traffic this will be strictly enforced.
18. Entry Fee is for a 20x30 foot space at K of C BBQ Smoke Off “4-Life”. The BBQ area is on a grassy field
19. BBQ Teams will receive additional information approximately one week before the event via email. Team location will be given at check-in. Teams are not permitted to set up their equipment outside of the designated setup times without prior permission.
20. Checks and money orders should be made out to Knights of Columbus Council #11917 and mailed to K of C BBQ Smoke Off “4-Life”, 5341 Swartz rd., Kansas City, KS 66106. Credit Card payments may be requested by Email. A 4% service fee will be added on.
